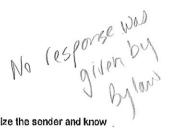

Hello and thank you for your prompt reply.

I'd just like to take a moment to express that making a formal complaint is not something that I, or any of the households in the affected area, take lightly. Those of us that have come forward as a result of this case represent a number of tax payers and residents with growing concerns over the impact to the local environment, quality of life, and for a community of families who have been here for upwards of 90 years.

In my initial bylaw complaint submission I outlined a number of specific incidents and concerns that we have had over the last decade; an industrial commercial business being run from a residentially zoned area, shipping containers, derelict vehicles, and other large machinery stored on the property, hazardous plastics being burned in an on-site incinerator, and recently a growing pig farming operation with the constant smell of manure throughout the summer all on/from the same residential property. Despite these incidences, increasing concerns over impact to and contamination of the surrounding environment, and the continued dismissal of any conciliatory efforts to address our concerns, we have not felt the need to formally file a complaint with the township until now.

The initial concern that brought us to this point is a wall of stumps, logs, brush, kindling, and other debris piled up beneath the Hydro right of way, running roughly a hundred and fifty feet long and reaching heights of eight feet tall. The unsightly wall (not a berm by definition) also runs alongside one of only two privately owned roads that access our entire area and are frequented by more than fifteen families. Surely this falls under the Clean and Clear Bylaw (Section 4.1b). In addition, the concerns over any fire hazards posed by this wall were raised several weeks ago by myself and a few others who represent a number of the affected households.

Since that complaint was filed, the family has been devastated by not one, but two fires, that erupted within a twelve hour period and destroyed their home. Words cannot describe the depths of despair that they are facing - I am truly heartbroken for their loss. Nobody should have to face that nightmare.

This very incident has once again raised many concerns and fears amongst our community over potential fire and safety threats. So we are once again reaching out to the bylaw enforcement office in the hopes that you sincerely and carefully consider this case, in its entirety (as outlined in MY original submission). Our hope and intent here is to find an amicable resolution for all involved parties so that the community can continue to peacefully coexist and support each other as neighbours who have lived side by side for many generations.

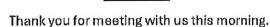

Not a problem at all, happy to help shed light on Wildland Fire topics,

I've reviewed both emails with photo attachments, and you are correct, I still maintain the humble opinion that the probability of this berm assisting head, lateral or backing Wildland Fire growth is nil. The course woody debris on the forested side of the burn would undoubtedly combust, in a stationary state, that would cause the responding agency to have to spend a great deal of time and effort to extinguish, however, it would not cause a ground fire to move quicker across the landscape in this current state, and in fact the berm would more effectively identified as a fuel break currently. In summary it would potentially slow a natural occurring Wildland Fires progress as it attempted to pass over the berm. It's simply going to take more water and time to extinguish if the course wooded debris were to catch on fire.

That being said there are many factors including forest/plant succession and human actions that could change the speed of which a Wildland Fire would pass over the berm as time goes on. For example, if a human was to choose to dump a pile of Christmas trees all over the berm after this seasons holidays, then the actions of placing multiple dead spruce, balsam and pine with dyeing needles would accelerate fire as it moved over the berm for the following fire season in 2025 if they Read Krister's Email asking) email asking) were arranged in such an manor. Another example is if the exposed soil is naturally re-seeded as a 100% spruce/balsam fir regeneration micro site, that site would increase in fire spread probability as the seedlings grew up until they get to the age of self pruning laddered branches.

Nice to virtually meet you, I'm not sure If I've met you in person or not at the twp, I'm also your Volunteer Captain Ken Cox of Stn. 80 Platoon Bravo,

Yes, as it happens I was on scene for a structure fire adjacent to the berm in question in late May, and this question came up after I had been present during 2 concurrent calls and I recollected personal observations of the berm to assist my answer on July 2nd as I had observed it before hand. Unfortunately, at this time the Aviation, Forest Fire and Emergency Services branch of MNR is not currently in a position to visit and assess municipal berm or similar issues vs. fire hazard complaints in person, therefore, I am unable to visit the site on behalf of the MNR at this time for this reason, however, in this unique occurrence I did have a solid recollection of the berm in question from my time on scene as a Captain and I used those berm observations, as well as Fire Chief French's description via phone call to support the standard response I am in a position to provide around these types of concerns to other Municipal, First Nation and Federal jurisdictions across Southern Ontario on similar matters.

My humble advice stands as for the berm in question at that time being a prolonged effort to extinguish for the municipal fire services if it had caught on fire as detailed below, However, in terms of assisting head, lateral or backing fire growth it would have been an micro barrier to that initial spread in its state, (meaning it would reduce fire growth) as the original complainant was concerned for and I was answering to. If since that time, additional fine fuels have been added to the location/berm by human action, it would change the effect of fire behaviour, you may absolutely send me pictures time stamped of the berm in question if you belief at any point the conditions have been altered since July 2nd, that may change the nature of the berms combustibility and you have additional concerns.

Regarding the concern of a burm located east of Halls Lake, and its association to a Wildland Fire Risk/Hazard; Burms/debris piles that are comprised of soil mixed in with course woody debris do not pose a risk to escaped containment or Wildland Fire containment, and do not pose a threat to Urban Interface incidents by assisting spread. In fact they quite often reduce spread rates from uniform forest fuel types pending time of year and successional forest/plant growth as the burm ages. The main factor burms play in relation to fire is prolonged efforts to extinguishment by a fire services if by chance the sparse wooded debris did catch fire and smoulder. The location in question is all Municipal, and Municipal Protection Area by your services. I have no mitigation concerns or see any risk of Wildland Fire problematic control from the burm in question from my MNR Provincial Fire Advisor role.

Thank you for your email.

In response to your concern regarding the berm being a potential fire hazard, staff have involved the appropriate internal and external departments/agencies to perform a thorough review.

The subsequent determination received from both the Algonquin Highlands Fire Department as well as the Southern Region Fire Advisor for the Ministry of Natural Resources have determined that the berm does not pose any wildland fire risk. Neither agency has any mitigation concerns nor see any risk of Wildland Fire problematic control from the berm in question. Alternatively, it was noted that a berm quite often reduces spread rates from uniform forest fuel types pending time of year and successional forest/plant growth as the berm ages.

Algonquin Highlands By-law staff have determined the berm would not meet the definition of Refuse (Section 2.20) as provided for under the Township of Algonquin Highlands Clean and Clear By-law as the berm has a planned and intended use. It will undergo natural regeneration of native species as well, will undergo deliberate plantings, so to blend into the surrounding natural landscape in time.

Part 4 Yards – Section 4.1 states: Every owner or occupant of property shall ensure the property, including vacant land is maintained free of:

(b) dead, decaying or damaged trees, branches, hedges, limbs and brush or other similar growth where it may create an unsafe condition;

The berm does not create an unsafe condition. By-law staff have advised the intention of section 4.1(b) is to ensure that any hazard standing trees do not pose a risk to the safety of others. In the case of the berm this section would not apply.

With respect to your other questions I can provide the following information:

- 1. We would like to know the name of this landscaping company, their description of a berm, and if their description matches with the Township's Official Plan.
- This information is not available or required by the Township as no Municipal approval is required for the subject work undertaken.
- 2. Is this allowed on a SR2 zoned property?
 - Yes. A berm is considered landscaping and is permitted within the SR2 Zone.

- 3. Proof that Ontario Hydro did an inspection and their report.
- Municipal approval is not required therefore we do not have a copy of any inspections or reports being undertaken by Hydro One.

In closing, the berm does not violate Township By-laws, nor does it create an unsafe condition. The file has been deemed closed based off a full investigation.

> Dear Mayor, Planner, Council Members and By Law officers of Algonquin > Highlands Township;
> We are lodging a formal complaint regarding the large pile of brush, tree trunks and tree stumps piled on property at property at which is zoned as SR2.
> Other have informed us that there have been three formal > complaints regarding this fire hazard sent to the By-Law officers to this date. These were not addressed adequately. Details can be provided regarding the township's response to these complaints. Upon hearing this we can't remain silent and would like to provide some context to this issue.
> Although our property does not share a property line with we are very close by and have been permanent residents for the past seventeen years. Our family has owned the property since the 1940s.
> When the family purchased the property in the 1980s, they inherited a reforested woodlot on the property. Unfortunately, at the time of purchase, this lot had not been maintained resulting in many dead trees that have been left to stand for decades. This has been a concern since it could easily go up in flames.
> Quite a few years ago who has had forest management experience, offered to start clearing out the dead trees. The family gave him permission and were grateful for his work. Nothing was done with this lot until two years ago when we have witnessed clear cutting and removal of stumps. Logs were pilled and removed. In late winter of 2024 dead trees surrounding the cleared lot were taken down and piled on the lot along with the stumps from the cleared area. Realize that the logs that make up of pile have been standing dead for decades.
> As claims in his letter to council, getting rid of stumps is very costly. His solution was to create a so called 'berm'. According to Algonquin Highlands By-Law 2023-11 the 'Clean and Clear By-Law' it clearly states in part 4.1 -Property maintenance section (b) that dead and decaying trees are not allowed on the property.
> We also know the cost of tree stump removal and followed the township's guidelines to have this done. In 2006 was hit by a tornado and sost many mature trees that were uprooted. The arranged with a sound to take the logs and paid for seven truck loads of stumps to be properly disposed of to the tune of several thousands of dollars. An unsightly pile of stumps and logs on our property would be illegal and a fire hazard. Note that property is also zoned SR2.
> Since the creation of this pile of dead logs and stumps on the property, we have noticed that once healthy trees adjacent to the pile, which are on the property, are dying.
